Subject: Extension in promotional plans "VVoBB-750" and "VVoBB-1000" for a further period of 90 days in all the Circles of North & West zones and introduction of uniform ISD tariff for Non-video calls throughout calling area including Gujarat Circle- reg.

Kind reference is invited to this office letter no. 1-1/2012-R&C [CFA] dated 23.04.2012 (circular No. 02/12-13) conveying approval of the competent authority for introduction of promotional plans "VVoBB-750" and "VVoBB-1000" in all the Circles of North & West zones for a period of 90 days w.e.f. 28-04-2012. Reference is also invited to item No. 4 C of letter No. 1-1/2009-R&C [CFA] dated 17-02-2012 (Circular No. 58/11-12) prescribing ISD tariff for non-video calls for VVoBB service.

2. Competent Authority has decided (i) to extend the above promotional plans for a further period of 90 days in North West Zone (ii) introduction of uniform ISD tariff throughout North West Zone at rates applicable for general landline subscribers for non-video calls made by VVoBB customers under regular plans as well as promotional plans.

Accordingly the approval of competent authority is hereby conveyed to extend the promotional plans "VVoBB-750" and "VVoBB-1000" for a further period of 90 days w.e.f. 27-07-2012 in all the Circles of North & West zones with the change as follows:-

"Usage charges for International non-video calls shall be chargeable as per regular ISD tariff applicable for BSNL landline service in all the North & West zone circles <u>including Gujarat circle on all</u> VVoBB Plans".

- 3. All other terms & conditions as issued vide R&C-CFA circular no. 02/12-13 dated 23-04-2012 & Circular No. 58/11-12 dated 17-02-2012 shall remain unchanged.
- 4. All regulatory requirements may kindly be compiled with while implementing the above tariff.
- 5. This Circular is issued based on the approval of Competent Authority in NWP-BB file No. 64-133/BB/Tariff/11-12/Pt.2.
