One Time upfront payment (for new customer)	Either to be obtained from DoT or from customers as per letter No. 105-1/2008-comml dated 18 th June 2008

2. The above tariff shall be applicable for all DSPT customers (i.e. commercial, Army & Para Military services).
3. The Circle should ensure to comply with all regulatory requirements.
4. **The above instructions shall be effective from 19-10-2017.**
