## Circular T&C-CM No. 113 /12-13

To The Chief General Manager, North Zone, East Zone Circles and Karnataka Circle.

Sub: Clarification on rationalization of tariff under 2G & 3G prepaid mobile services for North Zone & East Zone IN-reg.

Kindly refer to this office order of even No. dated 16.01.2013 vide which revision of tariff for General plan, Pyari Jodi, Student Special, Jai Jawan and Roam free plan were communicated. In view of technical non-feasibility reported by North Zone and East Zone IN, it has been decided by the Competent Authority to clarify/modify the tariff as under:-

## **North Zone and East Zone Circles:**

S.No.	Issues raised by the Ins	Clarification / Modification
(i)	The free Voice call Off-net under 1(A)(b) may be modified as Free Voice call Any -net, since there is no spare DA available in system.	➤ The Free Voice call Off-net under 1(A)(b)(i), to be modified from "Free Voice call Off-net" to "Free Voice call Any-net".
(ii)	The SMS in roaming under II (iv) (b) have been split as local and national. As per understanding, the local in roaming for SMS will be the circle to which subscriber belongs i.e. HPLMN. The same principle is already applied and working in case of SMS STVs while in roaming.	➤ In line with the suggestion given by North Zone IN, the SMS in roaming under point II.(iv)(b), "Local SMS" to be modified as "On-net SMS" and "National SMS" to be modified as "Off-net SMS" in order No. 26-04/2012-T&C-CM dated 16.01.2013.
(iii)	The free SMS being given at I(A)(iv) are On-net local & On-net national, but at present we have 2 DAs as Local & STD SMS.	➤ The Free P2P SMS at I(A)(iv) to be implemented as "Local SMS Any-Net" with free Local SMS of 25, 20 & 25 for General plan, Student special plan and Roam free plan respectively. No free national SMS in this case.

- 2. The implementation date of this office order dated 16.01.2013 mentioned above is extended by 2 weeks for North Zone, East Zone and Bangalore IN (Karnataka Circle).
- 3. All other terms and conditions will remain same.

- 4. This may be brought to the notice of all concerned for taking necessary action in this regard.
