Kindly refer to this office order of even No. dated 22.01.2019 (51/18-19) vide which new PV 25/26/28 & PV 72/73 was introduced under GSM mobile services. Based on queries raised by field units, the following clarifications/modifications are as under-

1.	Applicability of PV25/26/28 issued vide order No.26-07/2018-T&C-CM dated 22.01.2019	PV25/26/28 will be applicable for migration/validity extension only.
2.	Applicability of PV72/73 issued vide order No.26-07/2018-T&C-CM dated 22.01.2019	PV72/73 will be applicable for New connection/migration/validity extension only.
3.	Plan validity for PV25/26/28 and PV72/73 issued vide order No.26-07/2018-T&C-CM dated 22.01.2019	Plan validity for PV25/26/28 will be same as freebies validity i.e. 30 days. Plan validity for PV72/73 will be same as freebies validity i.e. 180days or 90(for J&K, NE-I/II, Assam) days.
