Kindly find enclosed CDMA Performance Monitoring report for the month of July-2013. On perusal of report, it is observed that number of BTSs having accumulated down time >24 Hrs in a month are quite large, specially for AP-63, AS-66, BR-130, HP-57, JD-54, JK-97, MP-48 & TN-31. Immediate attention is required by circles to minimise down time of BTS's. The circle wise details for parameters which are not meeting TRAI set BM in report are as given below:

BTSs accumulated downtime (not available for service in %age) (TRAI BM  $\succ$ <=2%):- BTSs accumulated downtime in respect of AS, BR, JK & UL Circles are 7.0, 26.3, 12.8 & 2.7 respectively.
