**ORDER**

- 2.0 The PCEs(E)/Sr.CEs(E)/ CEs(E) concerned shall take appropriate action regarding relieving / posting etc. of the Executives in order to comply the directions of Hon'ble Tribunal Hyderabad for implementation of judgment by 05.10.2011.
- 3.0 In case, the officer concerned fails to join his promotional assignment with-in the prescribed time period of 40 (forty) days, he/she should not be allowed to join the post thereafter. In such an event the promotion order shall become inoperative automatically and the matter shall be reported to this office for further necessary action.
- 4.0 If, any Executive desires leave, he/she can apply for leave to the Competent Authority only after joining the new posting .
- 5.0 The above promotions are provisional and shall be subject to the outcome of WP No 6578/2011 pending before Hon'ble High Court Hyderabad.
- 6.0 Vigilance clearance in respect of the Executives at Sr. No 3, 5, 6,8,12 & 13 are still awaited. PCEs(E)/Sr.CEs(E)/ CEs(E) concerned shall ensure that the Executives are relieved only if they are free from vigilance angle.
- 7.0 The position in the seniority list of the above Executives in the SDE(E) grade shall be as per the order of merit in revised result of LDCE held on 14.03.2002.
- 8.0 The charge report may be furnished to all concerned.
