ORDER

Subject: Promotion / posting of Accounts Officers/Sr Accounts Officers in the grade of Senior Time scale of Accounts and Finance Service on purely temporary and adhoc basis - regarding.

The following Accounts Officers/Senior Accounts officers, who are permanently absorbed in BSNL, are hereby ordered to officiate on ad-hoc basis in the grade of Senior Time Scale of Accounts and Finance Service in the IDA pay scale of Rs. 29,100-54,500 with effect from 30.8.2012 or from the date, their juniors were ordered to officiate in the grade of Senior Time Scale of Accounts and Finance Service on ad-hoc basis, vide this office promotion order No 2-12/2010 SEA BSNL dated 30.8.2012 in the circle, whichever is later, until further orders. Further, the officers on promotion to the STS on adhoc basis are posted in the circle mentioned against each below:

- 2. The promotion of the officers is further subject to the condition that no disciplinary/vigilance case is pending/contemplated against the officers. In case any disciplinary / vigilance case of the type referred to in DO P&T no 22011/4/91 Estt (A) dated 14.09.1992 is pending/contemplated against the officer or some punishment like stoppage of increment etc is current, he should not be promoted and the matter should be reported to SEA section and Vigilance branch of Corporate office immediately.
- 3. Before implementation of the order(s), the circle(s) must ensure that Presidential order for absorption of officers in BSNL has been issued and officers to be promoted are working in the grade of AO/Sr AO on regular basis. In case, the Presidential order is not issued and the officers are not working as AO/Sr AO on regular basis, the order should not be implemented and the matter should immediately be brought to the notice of SEA section of Corporate office, BSNL. Any request for declination of promotion will not be entertained by Administration due to administrative exigencies.
- 4. On promotion to the grade of STS on ad-hoc basis, the pay of the officers will be fixed as per the promotion policy issued vide O M No 400-61/2004-Pers I dated 18.1.2007 and PAT branch CO BSNL letter no 1-50/2008-PAT (BSNL) dated 5.3.2009 and further orders on the subject modified from time to time.
- 5. The above promotion is further subject to the condition that these officers may be reverted at any time due to administrative exigencies.
- 6. The above ad-hoc STS promotion will not bestow on the officers any claim for regular appointment to the higher grade nor will the service rendered by them in the grade of STS count for the purpose of seniority in the grade or for promotion to the next higher grade.
- 7. The Circle IFA concerned may intimate the station of posting of the officer (s) within 07 (seven) days from the date of issuance of this order. In case station of posting is not received, the officer(s) may be relieve with direction to report to concerned Circle for further posting.
- 8. The Circle IFA(s) are requested to relieve the officer(s) as early as possible without waiting for substitute. The officer(s) should be struck off from the roll of Circle latest by 15.10.2012 (A/N) and accordingly be deemed to have been relieved by the Circle on 15.10.2012 (A/N).
- 9. Posting of officer(s) to the sensitive/non-sensitive posts should be done by the Circle as per prescribed norms from time to time.
- 10. TA/TP may be regulated as per the guidelines issued by BSNL vide letter no. 19-27/2002-L&A (Part) dated 15.04.2004 modified from time to time.
- 11. Leave if any requested by the officer under transfer, should not be granted under any circumstances by the Circle (s) where they are working presently without prior permission of the BSNL CO. The officer can apply for leave to the Competent Authority at the new place of posting, who will sanction the same, if it is justified in the normal course.

- 12. Necessary charge report may be sent to all concerned including DM (SEA) CO BSNL.
- 13. This issues with the approval of the Competent Authority.
