- II) The name of reporting and reviewing officer of this reporting period may be intimated along with status of these officers whether in service or retired.
- III) Any action has been taken by Reporting officer in case self appraisal was not submitted by them, as per rule.
- IV) What is the status of the APAR by reporting officer and who is Reviewing officer, whether he is retired or in service.
