Subject: CMD Review meeting - Rationalization and redeployment of DG.

During the CMD review meeting with Dir(HR) held on 16.10.2020 it was observed that "With reduction in electricity consumption there is a requirement to rationalize DG set capacities and redeploy them accordingly "

In this regard the already issued following guidelines are reiterated for implementation and necessary action:

Issued vide	Guidelines
Point no. 9 of energy conservation of minutes of meeting of review meeting of CEs(Elect.) held on 09.01.2017( copy enclosed)	The oversized life expired DG Sets requiring frequent repairs may be scrapped on priority and replaced with DG sets of suitable capacity after proper load analysis. In view of rapid improvement in availability of power supply in most of the states, the DG sets will be required to run for shorter periods therefore the DG sets which are working satisfactorily even if they are oversized & life expired, should be replaced / redeployed only after proper cost benefit analysis.
Point no. 3 & 4 of roadmap of Project Ojas issue vide CMD D.O no. 1/OSD to CMD/Ojas/2018 dated 14.08.2018. (available on Intranet)	3.0 Review of demand and taking corrective action for disconnection, contract demand rationalization, closure of substation, downsizing of DGs etc. 4.0 Closure of DGs from urban/rural Exchanges/BTSs having reliable power supply from Utility Cos. and providing one mobile DG for a group of 20 sites in urban and 10 sites in rural.
Addl. GM(EW) letter No. 3-1-48/EW/2019 dated 02.08.2019 (available on Intranet)	DG sets may be discontinued on BTS sites having reliable power supply with average more than 20Hrs a day during last six months or sufficient capacity of battery bank is available. DG is to be disconnected and decision for shifting /scrapping may be taken within a period of 4 months. Provision of trolley mounted DG set may be made for any emergent situation in accordance to the extant guidelines issued under project OJAS vide CMD D.O no. 1/OSD to CMD/Ojas/2018 dated 14.08.2018.

No air conditioners and DG service are to be provided in the Exchanges having CFA revenue less than Rs. 10000/- per month and not having important services viz. OLT, transmission hub, leased lines, shared BTs , ILA (Intermittent line amplifier) etc. The existing air-conditioners and DGs may be disconnected immediately and decision for shifting /scrapping may be taken within a period of 4 months. A certificate may be required about this before allotting the fund for the building dues.

In addition to above where-ever power supply position is improved, if more than 1 DG set are there and subject to importance of site second DG set may be redeployed/scrapped as case may be. It will vacate the space and AMC cost will reduce.
