In accordance with directions from DoT, it has been decided to continue policy of Reservation Quota orders for M/s ITI Limited as per following.
(a) Reservation Quota orders will be placed against $30 \%$ of the requirement of BSNL for the products manufactured by M/s ITI Limited and $20 \%$ of the network roll out orders for the turn key projects (like GSM network roll out)of BSNL without any advance payment.
(b) $\mathrm{M} / \mathrm{s}$ ITI would accept orders under Reservation Quota only after the price is known and further, if the same is commercially viable.
(c) $\mathrm{M} / \mathrm{s}$ ITI shall exercise its option under Reservation Quota within 15 days of bid opening.
(d) This policy shall remain in force from 21-09-2013 upto 20-09-2014.
