On and from 28th November to 30th November, 2018. The pre-AIC Central Working Committee Meeting will be held at the same venue on 27th November, 2018. The Accommodation and food will be available from evening (Dinner) of 27th November, 2018 upto the morning (Breakfast) of 01st December, 2018 for delegates and from 26th November, 2018 evening to 01st December, 2018 morning for CWC Members, Circle Secretaries and CHQ Office Bearers.

upto and including October, All the Branches must clear their CHQ quota Circles/SSAs/Branches not having held their respective Conferences within time frame stipulated in the constitution must hold their conferences immediately to be eligible to attend AIC.

The election of the delegates is to be made strictly as per the provisions of the constitution and no Branch shall elect delegates in excess of the permissible limits. Even though there has been a very sharp increase in the cost of boarding/lodging and prices of essential commodities since our AIC at Jaipur in September 2015, yet to ensure that maximum Comrades (in accordance with the provisions of constitution) attend the conference, we are fixing the delegate fees @ Rs 1250/- per delegate. Thus the delegate fee for this AIC will be Rs 1250/- per head.
