

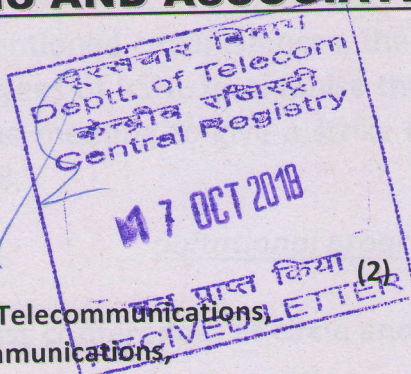

Sub: - **Non-implementation of the assurances given by the Hon'ble MoS(C) – issuing notice for agitational programme – reg.**

Respected Madam / Sir,

The meeting of the All Unions and Associations of BSNL (AUAB), which met on 08.10.2018, reviewed the progress in the implementation of the assurances given by the Hon'ble Minister of State for Communications, in the meeting held on 24.02.2018. The assurances are as follows:-

- (a) 3rd Pay Revision to BSNL employees.
- (b) Implementation of Government Rules in payment of Pension Contribution by BSNL.
- (c) Allotment of 4G spectrum to BSNL as per the proposal submitted by the BSNL Management.
- (d) Pension revision for the BSNL pensioners.
- (e) Settlement of left out issues of the 2nd PRC.

The meeting noted with regret that, even after the lapse of eight months, none of the assurances given by the Hon'ble Minister of State for Communications has been implemented.


In the meeting held on 24.02.2018, the Hon'ble Minister of State for Communications, also informed the representatives of the AUAB that, periodical review meetings could be held with the Secretary, DoT, to review the progress in the implementation of the assurances. However, despite repeated requests made by the AUAB, the Secretary, DoT, has not even met the representatives of the AUAB even once. The demonstration organised on 11th July, 2018 and the three day relay hunger strike organised from 24th to 26th July, 2018, by the AUAB, to attract the attention of the Hon'ble Minister of State for Communications and the Secretary, DoT, have also gone unnoticed.


Under the above mentioned circumstances, the meeting of the AUAB has decided to call upon the employees of BSNL to organise the following agitational programme. It is also decided in the meeting to give a strike call, if the issues are not resolved by 30th November, 2018.


agitational programme:


- (1) To hold press conferences at circle and district levels on 29-10-2018.

Date of the strike will be decided in due course.


