



Kindly refer to your letter No.5-1/2005-TW dated 15.5.2007 regarding the case of Shri Purushottam Meena for promotion to the Grade of SDE (Electrical). I would also like to invite your attention to this Commission's letter of even number dated 24.1.2005 in which BSNL was requested to keep in abeyance the process of DPC for the post of SDE (Elec.) till finalization of the case. These instructions may be treated to have been withdrawn by the Commission **subject to the condition** that the 12 vacancies reserved for STs in the grade of SDE (Electrical) are filled up by promoting ST category candidates in the feeder list including Shri Purushottam Meena by Non-selection method i.e. seniority-cum-fitness as per the amended Recruitment Rules. The Commission may be apprised of the action taken at your end within 15 days of the receipt of this letter.
