In this regard, the Online Registration data of the candidates of the LICE scheduled to be held on 22/05/2016 for promotion from Group 'C' to the grade of JTO (T), pertaining to your Circle is being forwarded to the Examination Coordinators of the Circles through their official E-mail ID provided by the Circles. In this regard, it is requested that the Cadre Controlling Authorities of the respective Circle should be directed to verify/scrutinize the eligibility of the candidates as per the eligibility criteria prescribed in the Recruitment Rules for the cadre of JTO (T), issued vide letter No. 5-32/2013-Estt. IV dated 14/10/2015 and subsequent clarification issued vide letter No. 12-1/2016-Rectt. dated 13/04/2016.

After verifying/scrutinizing the Online Registration data with the Service Particulars of the candidates, the Cadre Controlling Authorities are requested to furnish a report, indicating as to whether the candidate is fulfilling all the eligibility conditions prescribed in the Recruitment Rules and whether all the entries made by the candidate in his Online Registration data are correct or not. If the candidate is not eligible for appearing in the aforesaid LICE, the Cadre Controlling Authorities are requested to give detailed reasons thereof in their report.
