VISAKHAPATNAM, ANDHRA PRADESH.

For two days during 2/3rd week of February, 2022 (exact date will be intimated in due course). The pre-AIC Central Working Committee Meeting will be held one day prior to the AIC. The Accommodation and food will be available from evening (Dinner) of pre-AIC Central Working Committee Meeting day upto the morning (Breakfast) of the day after the Conference.

Circles/SSAs/Branches not having held their respective Conferences within time frame stipulated in the constitution must hold their conferences immediately to be eligible to attend AIC.

The election of the delegates is to be made strictly as per the provisions of the constitution and no SSA/District/Branch shall elect delegates in excess of the permissible limits. There has been a very sharp increase in the cost of boarding/lodging and prices of essential commodities since our last two AICs at Jaipur and Ludhiana, we are fixing the delegate fees @ Rs 1500/ per delegate. Thus the delegate fee for this AIC will be Rs 1500/- per head.
