- 2. The approval of the President is subject to adoption of requisite Board Resolution etc in accordance with the institutional framework prescribed by DIPAM in their Office Memorandum No. F 3/3/2018/DIPAM-II dated March 8, 2019 on monetization of assets and subject to the following additional conditions: -
  - (i) BSNL shall submit all the statutory documents to DIPAM through DoT viz. certified copy of Board Resolution adopted, particulars of Escrow Account and Certificates relating to litigation, encumbrance, etc.
  - (ii) BSNL shall explore all possibilities for converting the present Land Use to the required land use so as to make it saleable and realizing optimum value for the property.
  - (iii) BSNL shall ensure shifting of existing infrastructure and make alternate arrangements for smooth operation of services.
  - (iv) BSNL to make an exhaustive list of deficiencies in the records of all the assets and make efforts to update the records and also to ensure that there should not be any deviation from the prescribed procedure.
  - (v) BSNL shall carry out due diligence with all concerned for protecting the interest of the Company/Govt.
  - (vi) The Company shall ensure that Land record in the concerned CCA office is updated accordingly.
- 3. BSNL shall ensure compliance of monetization of assets in a time-bound manner and report the progress thereon to this Office periodically.
- 4. This issues with the approval of Hon'ble Minister for Communications.
