Circular R&C-CFA No. 45/22-23

Subject: Tariff for providing temporary Bharat Fibre connection in all circles.

1. In order to offer temporary connections on Fibre media, the competent authority has decided as below:

a) **Offer Temporary Bharat Fibre Broadband connection for short duration in all circles. Details are as below:**

S.No.	Particulars	Tariff
1	Minimum Plan FMC (Fixed Monthly Charges) for temporary connection	Rs. 799/-
2	Monthly Plan Charges for temporary connection	Three times of opted plan FMC
3	Security Deposit of Plan (Refundable)	One month FMC of opted plan
4	WiFi ONT Monthly Rental Charges	Three times of normal monthly charges, as introduced vide letter No. 1-1/2020-R&C(CFA) [Circular R&C-CFA No. 21/21-22 dated 25-06-2021]
5	Minimum Hire Period	One month
6	Static IP Address (on Request)	As per prevailing tariff order
7	Installation Charges	As per prevailing tariff order
8	Charges for the Overhead OFC	<ul style="list-style-type: none">NIL Charges up to 200 meter from OLTE location andRs. 40 per meter beyond 200 meter from OLTE location.


b) Above charges are excluding GST.

c) Revenue share with FTTH partners from above plan charges shall be distributed as per Fibre Policy and revenue share on ONT rental shall be distributed as per letter No. 1-1/2020-R&C(CFA) [Circular R&C-CFA No. 21/21-22 dated 25-06-2021].

d) Further, all the plans having FMC of Rs. 799/- and above under temporary connections shall be offered without OTT facility. Therefore, no revenue share to OTT providers in such connections.

e) Customers may be advised to opt dual band WiFi ONT to get optimum bandwidth.

- The circles shall ensure to comply with all regulatory requirements including on line reporting to TRAI and also update the circle website.
- The above instructions shall have immediate effect **in all circles**.
