Agreement for Self- execution of work by Mobile Tower Operators for providing Power Supply to locations of Mobile Tower

An Agreement made this the day of July 2022 between Bharti Hexacom Ltd (Pan No- AAACB2894G) a company duly incorporated and registered under the provisions of Indian Companies Act, 2013 having its registered office at- Bharti Hexacom Limited, bharticresent, 1, nelson mandela road, vasantkunj, phase II, New Delhi-110070 and having its administrative office at Bharti Hexacom Limited, Modrina mansion, 1st floor, laitumkhrah main road Shillong-793003, represented herein by its duly authorized Signatory Dandee T.W.Momin hereinafter referred to as the 'the Consumer' and which term shall include its successors and assigns) of the one part and the Meghalaya Power Distribution Corporation Limited an electricity distribution licensee under the EA, 2003 (hereinafter referred to as the 'MePDCL' and which in turn shall include its successors and assigns) of the other part.

Now, therefore, the parties hereto mutually agree as follows:

- 1. The Mobile Tower Operator shall submit separate application for each location to the Assistant Executive Engineer (AEE) Distribution Sub- Division.
- 2. On receipt of application, AEE (Distribution) shall, within 7 (Seven) working days of receipt of application, inform the Mobile Tower Operator of the following:-
- (a) Availability of load applied, indicating the source of supply (33/11 KV Sub-Stations) and name of the 11 KV Feeder.
- (b) Raise a Bill of Rs. 1.50 Lakh per location, as departmental charges.
- 3. The Mobile Tower Operator shall pay the Bill Amount of Rs. 177000.00 per location by NEFT/RTGS to the Principal Account of MeECL.
- 4. After payment is made to the above mentioned account, the Mobile Tower Operator shall submit detail of payments to the office of the AEE (Distribution).
- 5. The AEE (Distribution) shall, within 7 (Seven) working days of receipt of payment details, indicate the 11 KV tapping point to the Mobile Tower Operator.
- 6. The responsibility for arranging the Right of Way (ROW) / NOC/ Clearance from the competent authority for drawl of line is vested with the applicant.
- 7. The Mobile Tower Operator shall execute the work as below:-
- i. The Materials to be used shall be as per the specification approved by MeECL, notably, 9.5 meter GI poles for 11 KV Line and 8.0 meter GI Poles for L.T lines.
- ii. The materials/equipment shall be produced from approved vendors or manufacturers of MeECL.
- iii. The applicant shall engage only the Electrical Contractor approved by MeECL.
- iv. Metering shall be through pre- paid / thread- through system.
- v. The Applicant shall ensure that the construction or execution of the work is carried out as per the norm provided under the Electricity Act, 2003 and other prevailing rules and regulations of the State.

- After completion of work, the Mobile tower Operator shall inform the AEE 8. (Distribution) for Inspection.
- The AEE (Distribution) shall inform the AEE (Revenue) & AEE (Vigilance) for joint 9. inspection.
- The AEEs concerned, shall jointly inspect the work within 10 (Ten) working days of receipt of request for inspection and shall satisfy themselves that the work has been executed satisfactorily.
- The AEE (Distribution) shall then apply for charging approval from the Inspectorate 11. of Electricity, Government of Meghalaya.
- Maintenance of the 11 KV lines, DTs & LT lines create shall be vested with the Mobile 12. **Tower Operators.**
- That this Agreement shall bind and govern both the parties only for the purpose stated above, the MePDCL shall not be liable for any other claims or liability except for those 13. which has been specifically mentioned above.
- That this Agreement shall be valid till the aforesaid terms and conditions are fulfilled by both parties.
