**Subject: Limited Internal Competitive Examinations (LICE) for promotion of Group 'C' employees to the grade of Junior Telecom Officer (Telecom) [JTO (T)] in BSNL under 50% internal quota for vacancy year 2022 held on 27.08.2023 and addendum to Merit List issued on 13.10.2023 thereof reg.**

Please refer to the Merit list of JTO(T) LICE VY-2022 (held on 27.08.2023), declared on 13.10.2023 (available on BSNL Intranet portal).

2. After the declaration of Merit list & addendum, the discrepancies noticed/reported by Odisha Circle was received in this office. The data have been checked by Rectt Branch, BSNL CO also on the basis of information provided by the circle after the declaration of Merit List dated 13.10.2023 & addendum dated 06.11.2023 and it is found that:-

- i. Candidate Shri Pankaj Kumar Meena, HRMS NO. 60320009 registered his Parent Circle as Odisha at the time of registration instead of Gujarat circle as he was transferred under Rule-8 from Odisha to Gujarat circle. Hence, in this case his parent circle is Gujarat circle instead of Odisha circle. As notified vacancy, Gujarat circle does not have any further vacancy for the said Exam.

3. It thus appears that during e-verification, the aspect of Parent circle was not taken care of cautiously, due to which the candidate had to be removed from the merit list. The higher authorities have viewed the matter seriously and desired to apprise all concerned to be meticulous during e-Verification of eligibility.

4. Accurate and timely updating of duly verified data in SAP from service book as well as taking consideration of all the relevant parameters required for e-verification, ensures economy of time & resources at all level and all concerned in the process. Because of the discrepancies due to improper attention during e-verification leads to



delay in taking up further LICEs and thereby aspiring candidates gets deprived from appearing in subsequent LICEs in optimum time.

5. Accordingly, Candidature of Shri Pankaj Kumar Meena is deleted from the said Merit list against the Circle mentioned thereof because of inadvertent wrong/improper/inputs at different levels viz. Parent circle/ Recruiting circle/Transfer under Rule-8/Rule-9 etc. (Table 1).
