Sir,

I am directed to refer the above letters and subsequent reminders and to say that on the basis of information / details furnished by respective Circles, a Provisional Eligibility List-3 of JTOs has been prepared and the copy of the same is forwarded herewith. The said list of JTOs has been prepared based on the guidelines / instructions issued by DOP&T / DOT / BSNL from time to time.

The Provisional All India Eligibility List-3 of JTOs has been prepared for the Recruitment year 2009 to 2012 of all OC/SC/ST JTOs.

The said list (Annexure) may be given wide publicity among the concerned executives and objections / omissions / errors in the list may be intimated by the eligible officers to Corporate Office and to GM /DGM(HR) / Admn of respective Circles latest by 15<sup>th</sup> September, 2021.

The respective Circles may send all the objections / errors / omissions received on the subject to this office, after duly verifying from the service records available in the Circle Office by 29<sup>th</sup> September, 2021 on the email id: [agmpersdpcjm@gmail.com](mailto:agmpersdpcjm@gmail.com).

Circle should ensure the following:-


1. If any objections / errors / omissions received from the concerned, the Circle must send the data only in the prescribed format as circulated in the AIEL-3.
2. Recruiting Circles have to ensure that the required information of JTOs working in non-recruiting Circles pertaining to recruitment year 2009 to 2012 must be included in their Circle data after verification of their service record. While furnishing such data, the Circles should ensure to include the names of all JTOs of these recruitment years who got transferred under Rule-8, temporary transfer & on deputation, mentioning the same in remarks column etc.

3. Circles must ensure that, no JTOs pertaining to these Recruitment years should left to be included in the said list. Any claim in further whatsoever, , the responsibility will be with the concerned Circle only.
4. All the information forwarded to BSNLCO vide letter No..... dated..... for preparatory of AIEL-3 of JTO have been incorporated in said list.
5. All the DR-JTOs recruited under Special Recruitment Drive against PWD have been included in Provisional AIEL-3.
6. JTOs promoted against LICE 2013 in the year 2014, have been allotted Recruitment year 2012 as per Establishment Letter no. 5-6/2014-Estt-IV/3 dated 09.10.2018.
7. In case, if there is no correction or inclusion in the said list for any of the Circle, such Circles are requested to issue a 'NIL' certificate in this regard.
