**Subject : Periodical review for ensuring probity and efficacy among employees of BSNL.**

Kindly refer to various letters issued from this office on the subject mentioned above vide which it was requested to expedite the periodical review for ensuring probity and efficacy among employees on priority as directed by the worthy CMD, BSNL and send the review report of probity and efficacy for the calendar year 2022-2023.

As per the report received from the Circles (copy enclosed), the progress of review work of probity and efficacy in all the Circles (**except ITPC, BBNW, Haryana, J&K and West Bengal**) has been found to be unsatisfactory even after issuance of several reminders. The following is the review status as on 31.01.2024 of the Circles:

- AL TTC, CHTD, CNTx-E, KTK, MP, CNTx-NER, NE-I, NE-II, OR, Sikkim, TLG, TN, CNTx-W : **'NIL' review status since year 2022**
- Bihar, Gujarat, UP(W) : **Less than 25 %**
- AP, HP, CNTx-North, Punjab, Jharkhand, Kerala, MH, QA & inspection, UP( E) & Uttarkhand : **Less than 60 %**
- AN, CG, Rajasthan, CNTxWest : **less than 75%**

As the slow progress in periodical review for ensuring probity and efficacy among employees of BSNL especially for above Circles a & b has been viewed seriously by Competent Authority.

It is again requested, to kindly expedite the pending work of probity and efficacy on priority basis and direct the concerned officials to submit the updated review report in the prescribed proforma (Annexure VI-R) on priority basis on email ID [agmwsibsnl@gmail.com](mailto:agmwsibsnl@gmail.com) latest by 29.02.2024.
