Subject: Clarification on Combined residency period in Recruitment Rules of JTO(T)-2014-reg.

This is in reference to Note 11 below Schedule of JTO(T) Recruitment Rules-2014, which mentions as :


"....if two officials secure the same marks in JTO Phase I training, the seniority among them will be decided on the basis of combined residency period in the pay scale of Rs 13600-25420 or above in BSNL."

In this regard, a clarification was sought by Haryana Telecom Circle regarding the calculation of Combined residency period. This office has accordingly clarified the issue vide letter no. BSNLCO-A/16(27)/34/2022-ESTAB dated 22.08.2022 [Enclosed] with a copy endorsed to all CGMs etc. In continuation to the above, it is further clarified that:

1. The Combined residency period in the pay scale of Rs. 13600-25420 or above has been indicated in note 11 below schedule of JTO (T) RR-2014. Herein the pay scale of Rs 13600-25420 **includes all its pre-revised & post revised(if any) IDA pay scales including corresponding CDA scale.**
2. It is further clarified that the pay scale of Rs. 13600-25420 or above as mentioned in note 11 below schedule of JTO(T) RR-2014 is applicable on **TTA (now JE) cadre as well other cadres during DoT/BSNL period.**

Accordingly, the combined residency period in JE cadre as well as other cadres during DoT/BSNL period is ought to be calculated as per the clarification above.

Subject: Clarification on combined residency period in Recruitment Rules of JTO(T)-2014-reg.


I am directed to refer to your office letter no. HRCO-11/20(32)/4/2021-HR and ADMN dated 22.07.2022 on above cited subject

In this regard, it is intimated that as per the Note 11 of schedule of JTO(T) RR 2014, "**....if two officials secure the same marks in JTO Phase I training , the seniority among them will be decided on the basis of combined residency period in the pay scale of Rs 13600-25420 or above in BSNL.**"

Herein, it is clarified that the scale mentioned (Rs 13600-25420) is indicative of NE-9 scale which was Rs 7100-200-11175 (pre-revised) and revised to Rs 13600-25420 (revised on 01.01.2007 on 2nd PRC).

Accordingly, the combined residency period in JE cadre may be counted in NE-9 scale or above.
