Sub.:- Provisional seniority list (No. 2) in the grade of Sub Divisional engineer (C) as on 01.09.2023 from Sr. No. 178 onwards - Calling objections, representations, updation of data in ERP SAP reg.

- i. BSNL, circulated seniority list upto Sr. No. 1120 vide OM No. 5-3/2005/AD(BW-1) Dated 10.10.2017 which was further partially modified from Sr. No. 901 to 959 vide OM No. 23-1/2000-CSE/pt. dated 16.07.2018.
- ii. Provisional seniority list from Sr. No. 1121 to Sr. No. 2003 was circulated vide OM No. 5-3/208/DM(BW-I) dated 05.12.2018 and various objections were invited.
- iii. Final Seniority list from Sr. No. 1121 to Sr. No. 1671 was issued vide OM No. 5-3/208/DM(BW-I) dated 26.12.2019 by considering inter-se-seniority of SCF 2014 and LDCE 2014. Some modifications from Sr. No. 1075 to 1120A were also issued.
- iv. Provisional seniority list from Sr. No. 1672 to Sr. No. 2003 was not approved as LDCE exam. for VY 2013-14 onwards was not held.
- v. Further, after excluding all VRS opted/ resigned/ expired/ retired/ voluntarily retired/ technically resigned/ removed from service from the already approved seniority lists (from 1 to 1120A) and (1121 to 1671), a fresh seniority list as on 01.08.2020, with new serial numbers of seniority from 01 to 177 was circulated vide OM No. BSNLCO-BWHR/14(16)/2/2020-BW dated 16.10.2020.
- vi. Now, new provisional seniority list is circulated from srl no 178 onwards as below:
 - (a) From unapproved portion of provisional seniority list dated 05.12.2018 from Sr. No. 1672 to 2003, which has been updated as on 01.09.2023 by excluding the executives (VRS opted/ resigned/ expired/ retired/ voluntarily retired/ technically resigned etc.).
 - (b) From list of 57 number JTO(C) promoted to the grade of SDE(C) vide promotion order dated 30.12.2021 and dated 09.12.2022 by excluding the executives (Retired/ voluntarily retired/ Refused promotion etc.).
- vii. Keeping in view of the administrative requirement of the data pertaining to education qualification and PwD category in the seniority list, the concerned data from ERP SAP for each executive has been examined and incorporated in the provisional seniority list.
- viii. It is observed that number of data pertaining to educational qualification in the provisional seniority list is missing and may be incomplete also. Data pertaining to PwD category may also be incomplete.
- ix. This provisional seniority list is in continuity of seniority list dated 16.10.2020.
- x. Zones are requested to supply the missing data (If any) including updation of educational qualification and PwD category in ERP SAP and give wide circulation to the provisional seniority list among the incumbent executives.
- xi. Objections, if any, are called hereby from incumbents within a period of 30 days from date of circulation of this OM.
