Subject:- Annual Transfer and Posting of Officers in various cadres of Telecom/ Finance/ Civil/ Electrical/ Architecture/ Telecom Factory stream due to Promotion, Own request, Long stay etc., –Regarding.

The Officers listed in the enclosed Annexure-1, belonging to various cadres of Telecom/ Finance/ Civil/ Electrical stream are hereby transferred and posted to the circle indicated against their names with immediate effect and until further orders. Orders in respect of officers listed in the enclosed Annexure-2 are issued in partial modification to Order under Ref-3. Request of the officers listed in Annexure-3 will be considered on completion of process specified at SI.No.1 of Ref 4 and the said process shall be completed by November 2025.

- 1. Guidelines issued vide Ref-4, for the cases retained under Medical Grounds holds good for the officers considered in this Order and shall be followed scrupulously. The entire exercise has to be completed by November 2025 and a report to be submitted to Director HR under the signature of the Circle Head with specific recommendation.
- 2. Guidelines issued vide Ref-4, for the cases retained under immunity grounds being an office bearer of an Association also holds good and shall be applicable to the officers considered in this Order. Officers should submit an undertaking as prescribed in Ref-4 within one week from the date of this Order failing which the officer would stand relieved to the posted circle immediately.
- 3. It is observed that the eligibility of office bearers for immunity from transfer under REA rules are not being claimed and entered in ERP portal with the approval of the competent authority within timelines stipulated by BSNL CO from time to time and requests are received only after the issue of transfer Orders. Henceforth, requests for immunity under REA rules will not be entertained if the stipulated process is not completed before the issue of Transfer Order.

4. Officers retained for specific period shall stand relieved automatically on completion of the retained period without any further orders from BSNL CO. No representations shall be entertained on these cases.

5. CGMs to relieve the executives who have been ordered for transfer to other circles immediately but not later than 15 days from the date of issue of this Order. Further, no request for modification of posting order shall be entertained.

- 6. CGMs concerned are further advised that the pendency of request of the executives for modification of the posting order should not be taken as ground for holding up the implementation of this order.
- 7. The leave, if any requested by the executives, who are covered under this Order, should not be allowed. If any executive desires leave, he/she can apply for leave to new place of posting under whom he/she has been posted only after joining the new assignment. The new controlling executives will sanction leave, if it is considered justified as per norms.
- 8. Officers working at Tenure stations shall be relieved only on successful completion
- 9. All other conditions mentioned in the Order under Ref- 2, 3 &4 holds good and shall
- 10. Posting of executive(s) to the sensitive / non-sensitive post may be decided by the concerned circle as per prescribed norms circulated by DOT & Vigilance branch of BSNL Corporate Office from time to time.
- 11. The particulars of executives may also please be updated in the ERP as soon as
- 12. CGM concerned shall be responsible for ensuring strict compliance of these
- 13. Charge report may be furnished to all concerned and necessary entries be made in ERP/SAP/Service book accordingly.
