Provided that:

- No disciplinary/vigilance case is pending against him and VC is not withheld in terms of instructions contained in GOI (DOP&T) OM No.22011/4/91-Estt.(A) dated 14.09.1992, and also other relevant instructions.
- The currency of any penalty against the officer is over.
- The officer is not on deputation to any other organization.
- He has fulfilled the prescribed eligibility of three years regular service as per AO RR.

2. Further, the executive is promoted to AO subject to his Vigilance clearance to be ascertained by the respective circle. In case VC of the executive falls within the instructions contained in DoP&T order dated 14.9.1992 as referred above or is under currency of penalty, his promotion order may not be given effect and information in this regard may be brought to the notice of this office immediately along with the details of prosecution/suspension/disciplinary case/under currency of penalty, if any as the case may be. As such, the case may be kept as in "Deemed sealed cover."

3. The concerned CGM may please ensure that the promotion/posting order in respect of officer is issued in time to enable the officer to join his promotional assignment, within the prescribed time limit of 15 days (including the joining time).

4. In case the officer concerned fails to join the promotional assignments within the prescribed period of 15 days from the date of issue of this order, he should not be allowed to join the post thereafter. In such a situation, the promotion order shall become inoperative and the case shall be reported to this office. Further, no request for modification of posting order shall be entertained.

- iii. Subject to the outcome of SLP (C) No.011720/ 2020 filed by BSNL & titled as BSNL Vs Shri. M.G.Prabhakara Panicker.
- iv. Any other OA/ CWP/ SLP (C)/ CA etc., on similar/ connected matters pending in any CAT/ Courts.

10. The Seniority of the executive will be issued separately subject to final outcome of the pending Court cases on the matter.
