Integrity pledge for citizens and organizations enclosed at Annexure A and B. A poster on PIDPI has been prepared by CVC and is available at Annexure C. The poster may be widely circulated and translated to regional languages, wherever feasible. You may prepare your own posters too. An indicative list of activities which can be conducted as part of "Awareness Gram Sabhas" is at Annexure E.
- 5. In view of the above, it is requested to organize all activities as mentioned in enclosed CVC Circular during VAW-2023. Soft copy of the detailed plan in this regard may be sent to this office by 25.09.2023 at email id agmvahq@gmail.com & agmvahq@bsnl.co.in and its report may be incorporated in Vigilance Awareness Week Report.
